## HONORED SPEAKER

Mr. Vadim Perfiliev, Envoy Extraordinary and Minister Plenipotentiary

Mr. Vadim Perfiliev has served as the Director of the General Assembly and ECOSOC Affairs Division in the United Nations Secretariat (1994 - 2003). In that capacity, he was responsible for all aspects of preparation and orderly conduct of regular sessions of the General Assembly, including its First (Disarmament and International Security), Second (Economic), Third (Social and Human Rights) and Forth (Special Political and Decolonization) Committees and ECOSOC as well as of their subsidiary bodies.

Mr. Perfiliev supervised the preparation and conduct of GA the Special Sessions and of UN Conferences and Summits in New York and oversees. In August-September 2002, he performed the duties of the Secretary of the World Summit for Sustainable Development in Johannesburg. He has also supervised the Division of Palestinian Rights.

Mr. Perfiliev joined the United Nations in 1990. He has worked first as Director of the Dissemination Division in the Department of Public Information - DPI (1990-92). At that time he was responsible for the dissemination in the world of printed, electronic, audio and video information on UN, for accreditation of journalists, for public services, including guided tours, and for DPI accredited NGOs.

In 1992, Mr. Perfiliev joined the Department of Political Affairs and coordinated DPA and other Departments involvement in the peace process in Mozambique and Angola. He served as Director in the offices of the Special Representatives of the Secretary General in UN Operations in Mozambique (1992-1994) and in Angola (1994). He also took part in the UN advanced team to prepare the UN Operation in Cambodia.

In 2003, Mr. Perfiliev was the Regional Director for the Eastern Congo in the UN Peacekeeping operation in DRC (MONUC). He was responsible, in particular, for the coordination of MONUC activities in Bunia (Ituri). His presence in Bunia proved critical in the maintenance of relations with UPDF (departing Uganda Armed Forces), with senior local officials and of contacts with different warring armed groups. He was of great assistance in the organization of Ituri Pacification Commission.

Before joining the United Nations, Mr. Perfiliev was a carrier diplomat. In his national capacity, he specialized in multilateral disarmament affairs. He attended regular sessions of the UN General Assembly (Plenary, First and Special Political Committees) and the First Special Session on Disarmament as well as sessions of Geneva Conference on Disarmament and different bilateral negotiations, mostly with USA, as member of USSR delegations.

His last national position was - in perestroika and glasnost period - as First Deputy Chief of the Public Information Department and Deputy Spokesperson for the Soviet Union's Ministry of Foreign Affairs (1987-90) with the diplomatic rank of Envoy Extraordinary and Minister Plenipotentiary.

Mr. Perfiliev participated in organizing media aspects of summits of President Gorbachev with the Heads of State of the United States, France and other world leaders in Washington, Paris, Geneva, Rome, Kiev, Malta and other capitals. He served as Chief of Media and Political Sections in Soviet Embassies in Algeria, Belgium and France.

Mr Perfiliev has lectured at Universities in USSR and abroad. He has authored several publications on disarmament and public information issues. He has participated in joint projects of the USSR Ministry of Foreign Affairs and of UN Department of Public Information with Columbia University as well as of UN Political Department with Yale University. He served as Head of Examination Board of Journalism School of Moscow University of International Relations (MGIMO).

Mr. Perfiliev retired from the UN Secretariat and is now involved in the activities of DPI, UN Protocol and UN related NGOs. He is lecturing in Business School in Nancy, France, contributing to Russian media and participating in talk shows on New York based TV in Russian. He holds a master's degree in International Law from MGIMO and is married with two sons. He has one grandson and one granddaughter.



## MUNFW RULES OF CONDUCT

Model United Nations of the Far West strives to emulate the actual United Nations, and participants should also strive to maintain a professional decorum. It is the responsibility of the Advisor to inform their delegates of the proper conduct and behavior and to ensure their delegates conform to the guidelines during the annual session. If a problem arises with a delegate concerning these guidelines, the delegate's advisor will be asked to help resolve the situation.

#### Behavior in Committee

Committees are forums for discussion and creative solutions to global problems. Delegates are expected to be prepared, attentive, courteous and familiar with the committee's Rule of Procedure. Delegates shall address themselves to the chair or the entire body, at no time will delegates engage in debate or argue with each other directly. Delegates should not interrupt or be disrespectful during the speech of another delegate, nor should disagreements between delegates and the Chair over the interpretation of rules become a shouting match. At no time will delegates use foul language, or direct racial or ethnic slurs against a country or individual. Any of the above actions on the part of a delegate may be grounds for loss of credentials at the discretion of the Secretary-General.

#### **Behavior Outside of Committee**

The Secretariat hopes all delegates will take advantage of conference time to meet and get to know students from other schools and geographic locations. However, the Secretariat reminds delegates that there are appropriate times for these activities, both before and after committee session. When committees are in session, delegates are expected to be in their respective committee rooms.

Because we share the hotel with other groups and other guests, delegates are reminded to keep their noise to a minimum. Inappropriate behavior will result in action by the Secretariat, the hotel staff, or possibly the Burlingame Police Department. A delegate may be removed from the conference and/or hotel if s/he acts in a disruptive manner or is disrespectful to Secretariat members or other participants at the conference.

MUNFW shall maintain a security watch during the late evenings of conference. The security staff provides a buffer between delegates and hotel security. If any room is perceived as loud, MUNFW security will knock on the door and request that you quiet down. If MUNFW security returns to the room a second time, they will make a preliminary report to hotel security. If they return for a third time, hotel security will be called immediately and the occupants may be requested to leave the hotel.

#### **Alcohol Policy**

It is the policy of the Board of Directors of MUNFW to discourage alcoholic beverages from being brought to the conference site. For all receptions or group get-togethers taking place during the conference, the consumption of alcohol must be inside guest rooms. Drinking of alcohol in open containers or glasses in the hallways or in open doorways is prohibited. State law prohibits the serving of liquor to anyone without proper identification verifying that the person is 21 years or older. There shall be no alcohol permitted in committee rooms at any time. Any person or persons exhibiting disruptive behavior as a result of alcohol consumption will be requested to leave the conference immediately. No exceptions.

## BAY AREA RAPID TRANSIT (BART)

BART is the easiest method of transportation from the Hyatt Hotel into the city of San Francisco. The nearest BART station is located on Millbrae Avenue, approximately 1 mile from the hotel.

Please note that MUNFW does not provide tickets for travels to and from the city.

Please note that the last blue train leaving the Embarcadero station is at 12:43 a.m., arriving at Millbrae station at 1:23 a.m.

We recommend the following return options:

- 1. Take BART to San Francisco International. Airport (SFO) and take the hotel shuttle. You will need to call the hotel from the hotel kiosk inside SFO and ask them to send the shuttle to pick you up.
- 2. Take BART and walk to the hotel from the Millbrae BART station. Cross Millbrae Street at the traffic signal and turn left toward the bay. Cross over the freeway overpass bridge. Turn right on Old Bayshore Road. The hotel is about 34 mile south on your right.
- 3. Take a taxi. This is an option either from the city or from the Millbrae BART station.
